1. INTRODUCTION

- 1.1 Scottish and Southern Electricity Networks (SSEN) Distribution is obligated by schedule 2D of the Distribution Connection and Use of System Agreement (DCUSA) to submit biannually the Flexibility Market Price Statement with the current Flexibility Market Prices to the Secretariat for the licence area Southern Electric Power Distribution (SEPD). This is a requirement from 1st April 2023 following the Access Significant Code Review (SCR) changes to terms of connection for curtailable customers.
- 1.2 From 1st April 2023, and then by the first Working Day of each April and October thereafter, we are required to determine the Flexibility Market Import Price (in £/MWh) and the Flexibility Market Export Price (in £/MWh) and send the completed Statements to the Secretariat of DCUSA by the fifth Working Day of April and October in each year.
- 1.3 This statement by Southern Electric Power Distribution plc provides the Exceeded Import Curtailment Price and Exceeded Export Curtailment Price which has been determined in accordance with this Schedule 2D of the DCUSA. The Exceeded Import Curtailment Price applies to demand turn down or generation turn up and the Exceeded Export Curtailment Price applies to demand turn up or generation turn down for Curtailed Connections.
- 1.4 In this statement the Exceeded Curtailment Price has not been derived by any cost of reinforcement. At SSEN Distribution, we were able to use Flexibility Market Prices through flexibility service contracts and tenders.

2. FLEXIBILITY MARKET PRICE STATEMENT

2.1 The following table provides SEPD's Flexibility Market Import Price and the Flexibility Market Export Price which have been used to determine the Exceeded Import Curtailment Price and Exceeded Export Curtailment Price in accordance with Schedule 2D of the DCUSA.

5. IMPLEMENTATION OF FLEXIBILITY MARKET PRICE STATEMENT
